- 2. EACH VEHICLE TO HAVE A MINIMUM OF 3000 LIGHTS.**
- 3. IF PULLING A TRAILER BOTH TRUCK AND TRAILER MUST BE LIGHTED.**
- 4. NO HANDING OUT OR THROWING OF CANDY, ETC. ON PARADE ROUTE.**
- 5. DESIGN TO HAVE A HOLIDAY THEME.**
- 6. ALL MATERIALS TO BE FLAME RETARDANT.**
- 7. TRAILERS MUST BE SKIRTED.**
- 8. ALL RIGS TO CARRY A FULLY CHARGED FIRE EXTINGUISHER-WILL BE INSPECTION**
- 9. ALL GASOLINE FUELED GENERATORS MUST BE EXHAUSTED 12” OUTSIDE OF CONTAINED AREAS.**
- 10. NAME OF SPONSOR MAY BE NOTED HOWEVER, LARGE ADVERTISING BANNERS AND OR SIGNS WILL NOT BE ALLOWED.**

If you should have any questions please give us a call.

Lights must be miniature and can be any colors. **Initial** _____

No handing out or throwing any objects (including candy) along the parade route.
Violations of this rule will result in being suspended from future parades. **Initial** _____

You must agree to follow the rules/direction of the parade committee. **Initial** _____

You will be pre-assigned a staging arrival time and entry gate location. It is imperative that each entry arrives at that time and location. Entries arriving after 4:30pm will not be allowed to participate in the Festival of Lights Parade. **Initial** _____

Powered entries must have fire extinguisher the City of Palm Springs Fire Dept
Will be doing inspections this year to be sure you are in compliance. **Initial** _____

Please make sure your application is complete and legible. **Initial** _____

Santa or Mrs. Santa (live or replica) are not allowed on any entry **Initial** _____

Judging begins promptly at 4:45pm. **Initial** _____

No children walkers are allowed with any entry-if you will be having any walkers
you must note that on your completed application. They must be staged separately. **Initial** _____

Horses must be bagged or you must provide a clean up person to walk behind your
entry for clean up purposes. **Initial** _____

Approximately two days prior to the parade we will be holding a mandatory pre-parade
meeting for all entries. Each entry should send a representative; we will go over the
specifics of the parade and de-staging area. (Maximum of two) **Initial** _____

Maximum height for entries is 15 feet **Initial** _____

If pulling a trailer or a big rig with a trailer you must light both the truck and the trailer.
All of the trailers must be skirted. **Initial** _____

Check in closes at 4:30pm entries must be checked in prior to this time **Initial** _____

PRE-PARADE VEHICLE INSPECTION CHECKLIST

Name of Entry _____

Vehicle operator must have this Inspection Checklist in his/her possession the day of the parade. Drivers must check off and sign this Inspection Checklist and present it to the Parade Fire Officials inspecting parade vehicles prior to the beginning of the Parade. Once the Fire Officials have completed their inspection, a permit will be issued.

1. Driver has 180-degree field of vision, or approved communication with spotters. Driver_____ Fire Official_____
2. Driver has proper ventilation. Driver_____ Fire Official_____
3. Driver has valid driver's license. Driver_____ Fire Official_____
4. No Smoking allowed on/in vehicle during parade. Driver_____ Fire Official_____
5. No extra gasoline may be carried on the vehicle in the parade. Driver_____ Fire Official_____
6. Vehicle has a UL approved 2A-10BC classification fire extinguisher, which has been bought or serviced within one (1) year, in reach of the driver. Driver_____ Fire Official_____
7. Operating horn or other approved warning device must be present. Driver_____ Fire Official_____
8. All decorative materials used must be flame retardant. Driver_____ Fire Official_____
9. Brakes are in good working order. Tires have legal tread depth. Driver_____ Fire Official_____
10. Towed trailers or towed floats must have safety cables or chains in place and attached to the towing unit: towing hooks, front and rear are accessible and of sufficient strength for towing.
Exception – "king pin" attachments. Driver_____ Fire Official_____
11. Exhaust pipe is free of leaks, extends at least 12 inches beyond the apron. Where the exhaust pipe is within 12 inches of the apron (any direction) the exhaust pipe is to be protected from lagging.

12. Each standing rider must have approved body support. Driver_____ Fire Official_____
13. Generators and Portable Generators, if used, must be securely mounted. Approved installation needs to separate decorative materials from the generator. Generators must be equipped with a metal exhaust. This could terminate in either a common exhaust (vehicle and generator) or extend to the exterior of the float, same as the vehicle exhaust.
